



Lock/Unlock and Insert of the BRICK(2) STORAGE(*plus*)

The LOCK/UNLOCK button has no function. The BRICK(2) STORAGE(*plus*) is not hot plug capable.

Insert or removal of the BRICK(2) STORAGE(*plus*) during operation can cause data loss.

- Make sure your system is shut down before you insert or remove the BRICK(2) STORAGE(*plus*) cartridge.
- Insert the BRICK(2) STORAGE(*plus*) cartridge into the STORAGE BAY from the front side.

🔥 Warning!

▶ For safe and proper operation, follow the instructions in the manual and in the Quick Start Guide before you use the device. You can find the Quick Start Guide in the shipping unit.

You can find detailed information about the product in the manual "BRICK" or "BRICK2".

Use of BRICK(2) STORAGE(*plus*) (hereafter called "product") can cause damage to property and/or bodily injury.

- ▶ Read the product documentation and the terms that follow carefully.
- For positioning and installation or removal of the device, observe the relevant instructions in this user manual.

Installation

🔥 Warning!

Unless specified otherwise (e.g., by a specified IP class in the data sheet), the product is not protected against the penetration of liquids and foreign objects.

- Therefore, the product must be protected from ingress of liquids, foreign objects and dust. If this is ignored, there is a risk of electric shock to the user or damage to the product which can in turn lead to personal injury
- Choose a suitable operation location to protect the product against the ingress of liquids, foreign objects or dust. If you do not take the necessary precautions, the user may suffer electric shock or the product itself may be damaged which can also lead to personal injury.

Initial Operation

🛕 Before you start

The unit has undergone a comprehensive final check to guarantee that it has left the facility in a perfect condition.

Specifications

- Only use the product within the specified temperature and humidity ranges. The environmental specifications which are listed in the product documentation or in the data sheet must be observed.
